As you know, staff approved the Barlow Trail Veterinary Clinic to be located at 38950 Pioneer Blvd on August 8, 2023 (File No.22-041 (DR/ADJ). Per the Final Order, this approval is effective until August 8, 2025, two years from the date it was approved.

As allowed by Section 17.90.70. of the Sandy Development Code, with this application the applicant requests this approval be extended for one year to August 8, 2026.
